## **Section 5 – Fire Fighting Measures**

## **Section 6 – Accidental Release Measures**

**Accidental release:** Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. ## **Section 7 – Handling and Storage**
