## **Section 5 – Fire Fighting Measures**

**Fire and Explosion Hazards:** The major hazard in fires is usually inhalation of heated and toxic or oxygen deficient (or both), fire gases. ## **Section 6 – Accidental Release Measures**

**Accidental release:** Minor spills do not normally need any special clean-up measures. In the event of a major spill, prevent spillage from entering drains or water courses.
