Section 6 – Accidental Release Measures

Exposure Standards: A time weighted average (TWA) concentration for an 8-hour day, and 5-day week has not been established by Worksafe Australia for any of the major ingredients in this product. There is a blanket limit of 10mg/m³ for dusts or mists when limits have not otherwise been established. The nature of this product makes it unlikely that this level will be approached in normal use.
