**Section 6 – Accidental Release Measures**

**Emergency procedures:** Eliminate all sources of ignition. Increase ventilation. Avoid walking through spilled product as it may be slippery. Stop leak if safe to do so. Use clean, non-sparking tools and equipment. Avoid heat, flames, sparks and other sources of ignition. Use personal protective equipment.

**Methods and materials for containment clean up:** Soak up spilled product using absorbent non-combustible material such as sand or soil. Avoid using sawdust or cellulose. When saturated, collect the material and transfer to a suitable, labelled chemical waste container and dispose of promptly. Stop leak if safe to do so.

**Environmental precaution:** Do not allow product to reach drains, sewers or waterways. If product does enter a waterway, advise the Environmental Protection Authority or your local Waste Authority

**Section 7 – handling & storage**

**Handling:** Ensure an eye bath and safety shower are available and ready for use. Observe good personal hygiene practices and recommended procedures. Wash thoroughly after handling. Take precautionary measures against static discharges by bonding and grounding equipment. Avoid contact with eyes, skin and clothing. Do not inhale product vapours. Frozen material may be thawed in a warm room. Avoid localized overheating. Vent drums while heating. Mix thoroughly to assure homogeneity.

**Storage:** Store in a cool, dry, well-ventilated area. Keep containers tightly closed when not in use. Inspect regularly for deficiencies such as damage or leaks. Protect against physical damage. Store away from incompatible materials as listed in section 10. Avoid freezing or excessive heat. This product is not classified dangerous for transport according to The Australian Code for the Transport of Dangerous Goods By Road and Rail.
